Dear Parents/Carers of Year 4 children

Please can you help me with something?

Would your child like to be involved in a project that changes how we teach and learn?

I am currently studying for the National Award for SEN Co-ordination and plan to carry out a small research project in Year 4. The aim of the project will be to help all children work more independently and resiliently, making greater use of the classroom's 'working walls'. Our working walls are useful, but could be used more intensively by all children. We would like their advice on what to change for the better.

Who is involved?

This request letter has been sent to the families of all children in Year 4. I will work with a group of about five children from across the four Year 4 classes. Depending on responses, I will choose a range of children, of both genders, of a range of abilities and from different classes.

How long for?

The project will last about six weeks.

What will my child be doing?

They will be asked to say how useful they find the current working walls. They will be asked to suggest an additional feature that they would find useful. We will then choose one of the suggested features and implement it across the year group for six weeks. The children will then be asked whether they found the feature useful and if it improved their learning in class. Commitment from the children will be:

- A learning walk one afternoon with a small group of children and myself to identify things they like and do not like about working walls;
- Shortly afterwards, a conversation with the group of children, myself and another adult about which of their suggestions we will choose;
- Six weeks or so later, a second learning walk one afternoon with me and the same group to look at the working walls and identify any changes.

What if they don't enjoy it?

Children will be able to withdraw themselves at any time, or you may withdraw them at any time for any reason.

Why is it a good thing?

The children will be able to help design improvements to our working walls. We know that thinking about *how* we learn helps us to learn. Your child will be able to think about what they need to learn more effectively.







All information about the children will be kept confidential and no photographs of them will be used in the final report. Children's names will be changed to protect them (as indeed will the name of the school and county). Teachers and learning support assistants will also be anonymised.

Children will also be asked for their permission, but only once you have given your consent. I will let you know if your child will be taking part.
